

#### **Operations/Traffic Statistics** - Volume Data









# **Registrations—Toll Exempt Trips**

The total exempt vehicle registrations increased to 9,118 through December 2016. Hybrids comprise 45% of the total registrations, while High Occupancy Vehicles (HOV) like 3+ carpools, vanpools and transit comprised the other 55%. The Weekday Toll Exempt Trips and Peak Period Toll Exempt Trips for this month are shown by classification below for each segment. On average, 49% of all Hybrid trips occurred during the Peak Periods for December 2016.


